- I. The October minutes were emailed out prior to the meeting and there were no additions or changes voiced.
- II. Introductions

There were no new members on the meeting.

III. Trauma Regulation Update

Nicole said there is plans for the Dept to look at the regulations.

IV. Trauma Statute update

Nicole updated the group that MHA plans to reintroduce HB 1295 and the pre-file for that bill should be in Dec or early Jan. The MHA is working with MOCEP to try to make the language appropriate for all.

V. Data

No data was requested of the state this month.

Nicole stated that Image Trend presented a "Short Report" that showed firearm related incidents in pre-hospital settings. Nicole said she would pass along the link to this report. She said they reported that the Midwest has seen the largest increase in gun related violence with about an 85% increase between 2018 and 2020.

Pam discussed an issue that has been found when uploading patients from Digital Innovation software to the Image Trend software at the state that patients that are coded as a penetration are changed to a burn. Nicole said that the state had their point person for Image Trend try to re-create that with Image Trend, but it could not be reproduced. There has been no info back from DI. Nicole encouraged the group to develop a report card or trend to report on.

VI. SAC Pediatric Subcommittee Report

Josh Dugall reported that EMS data was presented at their meeting. He reviewed the top five pediatric chief complaints that Nicole presented at their meeting according to the complaint EMS was dispatched for from the 911 operator or dispatch. This data is out of almost 23,000 calls for pediatrics. Below are the top five list in order.

- 1. 4300 were for interfacility transfers for all complaints
- 2. Behavioral health complaints
- 3. Respiratory problems
- 4. MVC (including all types of vehicles)
- 5. General traumatic injury

The group discussed ATV accidents. So far, year to date there have been 188 kids involved in ATV accidents. He said the group is going to work to refine the questions for the query to be able to get the most helpful data. He said Steve Bolin joined their meeting to discuss how TCD can be incorporated in pediatrics. They have four pediatric emergency medicine physicians and trying to get their input on time critical diagnosis as it relates to kids.

There was discussion about finding out how many pediatric patients died from MVCs. Nicole said she could do some investigation with MODOT to try to find the information.
