

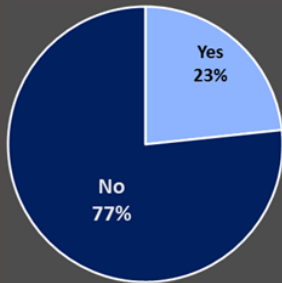
MO-HOPE Project Impact and Sustainability Survey Results

The MO-HOPE Project team surveyed representatives from partnering agencies to collect information about what they have gotten from the MO-HOPE project as well as assess for sustainability plans.

60 Responses from Partners



77% of respondents indicated that they do **not** have an additional source of naloxone



Does your agency have any plans to acquire additional naloxone outside the Missouri's SAMHSA grants?

"Our ability to offer naloxone to our population of clients would be greatly reduced"

THE MO-HOPE PROJECT CONCLUDES IN **2021**. THEREFORE, IT IS CRITICAL THAT WE BEGIN TO PLAN FOR SUSTAINABILITY TO ENSURE THAT ACCESS TO OVERDOSE EDUCATION AND NALOXONE CONTINUE.

STEPS YOU CAN WORK ON NOW

- 1 START HAVING CONVERSATIONS ABOUT THE BENEFITS OF CARRYING NALOXONE AND/OR BEING ABLE TO DISTRIBUTE NALOXONE TO THOSE YOU SERVE.
- 2 COMPILE DATA RELATED TO OVERDOSES IN YOUR AREA TO DEMONSTRATE NEED OF NALOXONE. FOR OVERDOSE DEATH DATA, VISIT THE DEPARTMENT OF HEALTH AND SENIOR SERVICES OPIOID DASHBOARD ([HTTPS://HEALTH.MO.GOV/DATA/OPIOIDS](https://health.mo.gov/data/opioids)). TO REQUEST OVERDOSE REVERSAL DATA COLLECTED THROUGH THE OVERDOSE FIELD REPORT SYSTEM, EMAIL: MOHOPEPROJECT@MIMH.EDU
- 3 ADVOCATE FOR NALOXONE TO BE ADDED TO YOUR AGENCY BUDGET AND/OR ADVOCATE AT THE STATE AND FEDERAL LEVEL FOR CONTINUED FUNDING FOR NALOXONE.
- 4 ESTABLISH AN OVERDOSE EDUCATION AND NALOXONE DISTRIBUTION TRAINER WITHIN YOUR AGENCY. SEND THIS REPRESENTATIVE TO A MO-HOPE TRAIN-THE-TRAINER SESSION. FOR TRAINING OPTIONS, VISIT: WWW.MOHOPEPROJECT.ORG/TRAINING
- 5 CREATE A PLAN FOR ACQUIRING NALOXONE OUTSIDE THE MO-HOPE PROJECT (SEE BELOW).

DIRECT RELIEF MEDICATION DONATION PROGRAM

COMMUNITY HEALTH CENTERS, FREE AND CHARITABLE CLINICS, PUBLIC HEALTH DEPARTMENTS, FEDERALLY QUALIFIED HEALTH CENTERS, AND OTHER NONPROFIT PROVIDERS NATIONWIDE MAY BE ELIGIBLE TO RECEIVE FREE INTRAMUSCULAR NALOXONE THROUGH DIRECT RELIEF. FOR FEDERAL AND STATE GOVERNMENT AGENCIES AND TRIBES, (INCLUDING THOSE AGENCIES WHO RECEIVE FEDERAL GRANT FUNDING TO ADDRESS THE OPIOID OVERDOSE EPIDEMIC), KALÉO OFFERS A PURCHASE PRICE OF OF \$180 PER AUTO-INJECTOR OF EVIZIO (\$360 PER PACK OF TWO AUTO INJECTORS AND A TRAINER) WHEN PURCHASED DIRECTLY FROM KALÉO. THERE ARE MANY DISTRIBUTORS THAT SELL INTRAMUSCULAR NALOXONE (VIAL AND SYRINGE). PRICING TYPICALLY RANGES FROM \$15-30 PER DOSE (INCLUDES VIAL AND SYRINGE).
